Weather is warming up but remember that Tuesday morning and Saturday morning games are at 9:30 when temperatures are very comfortable. You will notice a competition chart on the stand near the bulletin board. The event runs from 1 July through 1 October. We will use this to determine the 2018 club champion. Every time you come to play, place a white pin in the hole under the date on your name line. I will cross check with the sign in book to be sure you get your one point for showing up. After the match, if you win your game, replace the white pin with the appropriate colored pin to earn points depending on the match you played. Pins are on the bureau next to the stand. Every club member is entered into the tournament. There will not be a separate, designated "Club Champion Tournament". We will tally your cumulative over the next 3 months to determine the winner. Focal Point: Bowl Displacement

Bowl displacement by another player

If the bowl is displaced by a member of the team that delivered the bowl and it has not disturbed the head after it is displaced, the opposing skip must declare the bowl dead.

If the bowl is displaced by a member of the team that delivered the bowl and it has disturbed the head after it is displaced, the opposing skip must: replace the head and declare the bowl dead.

If the bowl is displaced by an opponent and it has not disturbed the head after it is displaced, the skip of the team that played the bowl must choose whether to: have the bowl replayed; place the bowl where the skip believes it would have come to rest; or leave the bowl where it came to rest.

If the bowl is displaced by an opponent and it has disturbed the head after it is displaced, the skip of the team that played the bowl must choose whether to: replace the head and have the bowl replayed; replace the head and place the bowl where the skip believes it would have come to rest; or declare the end dead.

If a bowl has disturbed the head before it is displaced by a player, this disturbance is valid. (The opposing skip must not replace any part of the head that has been disturbed before the displacement.)

If a bowl in motion is displaced by a player and it has not disturbed the head after it is displaced, the opposing skip must choose whether to: place the bowl where the skip believes it would have come to rest; or declare the end dead.

If a bowl in motion is displaced by a player and it has disturbed the head after it is displaced, the opposing skip must choose whether to: place the bowl where the skip believes it would have come to rest and replace any part of the head disturbed after the displacement; or declare the end dead.

Goals 2018:

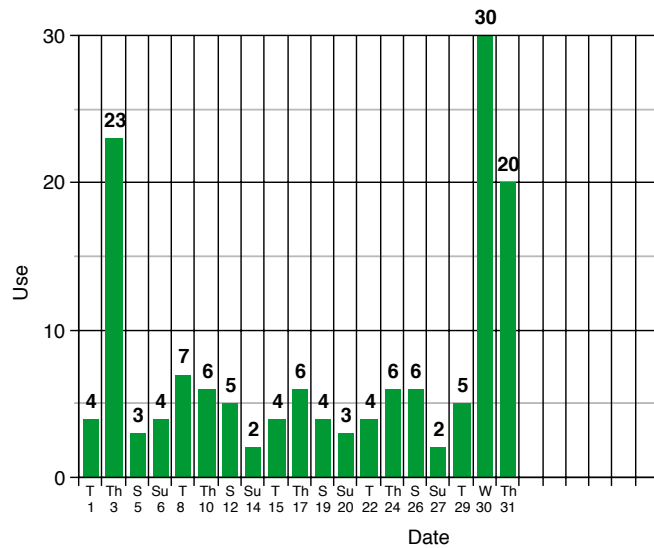
Personnel: to have a net gain of 5 on our January 30 membership roster
